As you are aware the site on Wall Loop Road has been identified as the most favorable for the elevated water storage tank by LKC Engineering as part of the Stokes-Danbury /Meadows Water System Interconnection Project. The total projected height is 175 ft. and will hold approximately 100 gallons of water. 
