The Stokes Soil and Water Conservation District (SWCD) was organized in July 1960 and encompasses an area of 458 square miles consisting of 287,269 acres. The Stokes SWCD is a locally controlled, special purpose governmental

subdivision of the State of North Carolina and is governed by a Board of Supervisors. The District Supervisors are charged with the responsibility of promoting soil and water conservation and establishing conservation programs in the county. Members of the Board serve four year terms with three seats being filled in the general election and two seats being appointed by the North Carolina Soil and Water Conservation Commission.

Board meetings are open to the public and are held the third Wednesday of each month at 9:00 a.m. in the Old Courthouse Office Boardroom in Danbury.

#### Our Mission

The mission of the Stokes Soil & Water Conservation District is to administer and support local, state and federal programs to the community and to educate citizens and disseminate information regarding the preservation of our natural resources.

## NC Agriculture Cost Share Program

The NC Agriculture Cost Share Program (NCACSP) is administered by the Stokes SWCD to reduce non-point source pollution caused by agriculture. In the 2024-25 fiscal year <u>5 contracts</u> were approved totaling <u>\$60,894</u> which included funds from NCACSP and Impaired/Impacted. The following best management practices were installed during the 2024-25 fiscal year:





## Practices Installed Livestock Exclusion

The installation of the practices listed above affected 658 acres by decreasing soil erosion and reducing the transport of valuable nutrients <u>resulting in a total of 979.6 pounds of nitrogen saved, 303.7 pounds of phosphorus saved, 140 tons of soil saved.</u> Program spot checks for NCACSP, Impaired/Impacted, and AgWRAP are conducted annually by randomly selecting a minimum of 5% from the active contract pool of

each program. On April 23 and May 21, 2025, staff members along with Board Members visited 6 randomly selected sites and performed spot checks of installed best management practices; all were found in compliance. Pictured above are best management practices for a stream exclusion system installed in the 2025 fiscal year; (top) BEFORE picture of streambank erosion due to cattle accessing the stream; (bottom) AFTER picture showing installation of exclusion fencing at least 10 foot from the top of the streambank.



## Streamflow Rehabilitation Assistance Program (StRAP)


The NC Streamflow Rehabilitation Assistance Program (StRAP) is a new program that provides grants to projects that restore and protect drainage infrastructure of both natural streams and small watershed structural projects to prevent future flooding and reduce risks to life and property. Stokes SWCD staff applied for and received \$524,718 through StRAP in the 2024-2025 fiscal year. Part of the funding will be used to remove ~2,500 cubic yards of sediment and debris from the LY-25 watershed structure that had accumulated over time and was hindering the function of the structure as a whole. The rest of the funds will be used to remove debris from 7 segments of stream (totaling 10,979 linear ft.) returning the streams to their natural flow. Work began in May 2025 and will continue throughout the winter into 2026.



#### Flood Control Structures - Watersheds



The USDA Natural Resources Conservation Service has designed and constructed 24 flood control structures in Stokes County over the past 60 years. These structures provide flood control for 56,579 acres in the Town Fork Creek (TFC) watershed area and 36,536 acres in the Little Yadkin (LY) watershed area. The Stokes Soil & Water Conservation District is responsible for the maintenance of these flood control structures which includes mowing, fertilizing, liming and debris/brush removal on 75 acres.





The Stokes SWCD Board and office staff conducted annual watershed inspections on October 16, 2024. During these inspections toe-drain pipes were cleaned out, risers were checked for debris, and the front, top and backside of dams were checked closely for any eroded areas, leaks or scouring holes.

## No-Till Seed Drill

During the 2024-25 fiscal year the Stokes SWCD no-till seed drill was used to <u>reseed and/or establish 298 acres</u> of hayland, pastureland, and wildlife plantings in Stokes County. The drill was purchased through a grant from the NC Foundation for Soil & Water Conservation in 2008. A no-till drill promotes soil health by minimizing disturbance, reducing erosion, improving moisture retention, and enhancing seed placement for stronger crop establishment.

## Conservation Easements

The Stokes SWCD currently holds 3 conservation easements consisting of approximately 18.21 acres along areas of the Dan River and its tributaries in an effort to protect riparian buffers for the benefit of water quality and to protect and maintain the river in its natural state. These <u>easements were inspected by staff on April 30 and May 15, 2024 using a drone to capture aerial views of each site.</u>



## Voluntary Agricultural District Program

The Stokes County Voluntary Agricultural Districts (VAD) program promotes agricultural values and general welfare of the county by increasing identity and pride in the agricultural community and its way of life, encouraging the economic and financial health of agriculture, and increasing protection from non-farm development and other negative impacts on properly managed farms. Members of the 2024-25 VAD Board were: David Ferguson, Josh Francis, David Jones, Bob Cooke, Sloane McPeak, Randall Patterson, Meredith Tedder.

The Stokes SWCD, along with the Cooperative Extension Service, advise and provide administrative support to the VAD Board. In the 2024-25 fiscal year a total of <u>14 new parcels were added to the VAD program preserving an additional 982.25 acres of farmland. There are currently 9,508.759 acres in the Stokes County VAD Program. Pictured above is a farm located in King enrolled in the VAD Program.</u>

#### Conservation Plans

The Stokes SWCD staff provides free technical assistance to landowners, when requested, by completing conservation plans that identify the landowner's conservation objectives and assesses and analyzes the natural resource issues on the land. In the 2024-25 fiscal year, staff wrote 34 conservation farm plans.

#### Water Point Certifications

Staff certify water point locations for local fire departments, at their request, through the Stokes County Fire Marshalls office. These certification points are stream and pond sites where water withdrawals can be safely obtained in the event of a fire. Soil & Water staff visit each site and determine water volume capacity and recharge rates by taking flow measurements. Once data is collected a discharge calculation formula is used to determine the water body's volume capacity and its ability to recharge after a withdrawal is made. As of the 2024-25 fiscal year, 18 water point sites have been completed for Stokes County. Pictured to the right is staff conducting a water point certification at a stream site.




## Staff Training & Professional Development


## Conservation Education

Each year the Stokes SWCD sponsors educational programs for all citizens of Stokes County. These programs educate individuals on the value of our natural resources. ## Environmental Awareness Days



Each spring the Stokes SWCD sponsors Environmental Awareness Days for 5<sup>th</sup> graders at Hanging Rock State Park (HRSP). At this event students rotate through stations learning about topics such as soils, wildlife, forestry, weather, functions of the human body, the water cycle, honeybees and animal ecosystems, all of which follow the NC Common Core Essential Standards for 5<sup>th</sup> grade science. The 2024-25 Environmental Awareness Days event was held on April 15 & 16 with 402 students and teachers participating. Pictured on the left are students at the soils tent learning about the importance of ground cover and how it affects erosion with a rain simulator.

## Resource Conservation Workshop

The Resource Conservation Workshop is a weeklong intensive study and hands-on conservation workshop held on the campus of NC State University each year for conservation-minded students in grades 9-11. Each Soil & Water District in the state is allowed to send at least one student representative to participate in the workshop. The District's select a student from a pool of applicants and then registers them for the competition by paying the \$625 registration fee which includes housing and meal costs. The Board selected Zinnia Burgess from South Stokes High School to participate in the 2025 workshop that was held on June 15 – June 20. Pictured to the right are students at this years Resource Conservation Workshop taking soil core samples.



## NW Envirothon Competition

The NW Envirothon is an environmental competition in which middle and high school teams from the northwest section of the state exercise their training and problem-solving skills by testing in categories such as soils/land use, aquatic ecology, forestry, wildlife and current environmental issues. The teams, each consisting of five students from participating schools, test as a group. The top scoring teams at the regional competition advance to the NC State Envirothon held each year in Alamance County in April. The Stokes SWCD sponsored 2 teams from South Stokes High School to compete at the event held on March 27, 2025 in Wilkes County. Stokes SWCD staff also processed registrations for the 26 high school and 21 middle school teams that participated this year as well as assisted with the current issues station, which included over 235 participants from across northwest NC.






## Farmer Appreciation Event

#### Public Outreach





The Stokes Soil & Water Conservation District produces and mails a bi-annual newsletter to over 2,400 citizens each year called "Soil & Water News". In this publication, announcements are made regarding all conservation programs offered and upcoming district events. The office staff also submits informative articles on new and innovative conservation techniques, Farm Bill updates, and grants that are Each newsletter is posted on the district website (www.stokesswcd.org). This up-to-date website introduces local board members, lists details of all cost-share programs, lists all educational programs and contests, answers frequently asked questions, presents an up-to-date calendar of events, links, and office contact information. The website has been in production since 2006 and continues to be a useful tool in getting the conservation message to the public. The Stokes Soil and Water Board has also recently approved a social media page on Facebook where you can find similar information. As another means of outreach, each fall the Stokes Soil & Water Conservation District displays a fair booth at the Stokes County Agricultural Fair. Thousands of people attended the fair annually, which was held on September 9-14, 2024.
